CALL FOR SUBMISSIONS: BOOK REVIEWS FOR THE *JOURNAL OF LAW AND POLITICAL ECONOMY*

The *Journal of Law and Political Economy* invites submissions for book reviews from scholars in law, the social sciences, and the humanities whose research seeks to expose mechanisms of structural inequality and to promote economic, political, and social justice in domestic, regional, or international contexts. We especially encourage submissions by scholars from the global South, and we welcome reviews showcasing scholarship produced outside the North Atlantic region. Reviews of scholarship published in languages other than English are also welcome. Book reviews are not subject to the *Journal's* double-blind peer review process.

BOOK REVIEW FORMATS

For the *JLPE* book review section, we invite contributions in the following formats:

- **Traditional book review:** Concise reviews of books published within the past 2 years (no more than 1,000 words). We encourage reviewers to provide critical analysis rather than simply summarizing the book. These reviews do not include a Reference List.
- **Review of classic works:** Longer reviews (up to 2,500 words) that reevaluate classic scholarly writings from an LPE perspective.
- **Book review essay:** Comprehensive essays (up to 8,000 words) surveying recent research and broader themes in a specific area of LPE scholarship. These essays should offer significant new insights, contribute to scholarly understanding, and propose directions for advancing the field. Review essays may focus on books, articles, or a combination.
- **Book review symposium:** A collection of approximately 4-6 book reviews (each up to 3,000 words) providing critical analyses of an important recent book.

ABOUT *JLPE*

With the conviction that conventional Law and Economics is inadequate to the multiple and overlapping crises of our time, *JLPE* seeks to promote multi- and interdisciplinary analyses of the mutually constitutive interactions among law, society, institutions, and politics. Our central goal is to explore power in all its manifestations (race, class, gender, sexuality, disability, global inequality, etc.) and the relationship of law to power. Accordingly, *JLPE* aims to provide an academic and practical resource for, and to foster discussion among, scholars, activists, and educators from countries around the world to build bridges among the diverse groups whose work engages and resists the legal foundations of structural subordination and inequality.

JLPE is an open-access, peer-reviewed journal that publishes original articles and book reviews. A project of ClassCrits, Inc., we are part of the Law and Political Economy Collective (LPE-C). Our sister organizations include the Association for the Promotion of Political Economy and Law (APPEAL) and the Global LPE Network. Our Editorial and Advisory Boards consist of distinguished, nationally- and internationally known scholars drawn widely from law, the social sciences, and the humanities.

STYLE AND FORMAT

Our [style sheet](#) is based on the Chicago Manual of Style, 17th edition (including its author-date system for in-text citations) and the ALWD system for primary legal sources. We welcome manuscripts produced in Bluebook or other formats, although we expect authors to conform their manuscripts to our style sheet after acceptance.
