

Publication Ethics and Malpractice Statement

i) Journal policies on authorship and contributorship.

Only persons who meet the following authorship criteria should be listed as authors in the manuscript, as they must be able to take public responsibility for the content: (i) made significant contributions to the conception, design, execution, data acquisition, or analysis/interpretation of the study; AND (ii) drafted the manuscript or revised it critically for important intellectual content; AND (iii) have seen and approved the final version of the paper and agreed to its submission for publication.

The corresponding author should ensure that all appropriate coauthors (according to the above definition) and no inappropriate coauthors are included in the author list, and verify that all coauthors have seen and approved the final version of the manuscript and agreed to its submission for publication.

All persons who made substantial supporting contributions to the work reported in the manuscript (such as technical help, writing and editing assistance, or general support) should be acknowledged in the “starred footnote” at the beginning of the article.

ii) How the Journal will handle complaints and appeals.

In cases where alleged or proven scholarly misconduct, fraudulent publication, or plagiarism is brought to the attention of the Journal, the editorial board will take all appropriate measures to clarify the situation and to amend the article in question if necessary. If valid misconduct complaints are received while an article is under review, the manuscript will be rejected. If misconduct is proven after an article is published, responses may include the prompt publication of an erratum, clarification or, in the most severe case, the retraction of the affected work.

iii) Journal policies on conflicts of interest / competing interests.

Authors should, at the earliest stage possible (generally by disclosing the relevant details at the time of submissions and including a statement in the manuscript), disclose any conflicts of interest that might be construed to influence the results or their interpretation in the manuscript. All sources of financial support for the work should be disclosed (including the grant number or other reference number, if any).

iv) Journal policies on data sharing and reproducibility.

JLPE is committed to a more open research landscape and facilitating access to research by enabling reproducibility. JLPE encourages authors of articles published in the Journal to share their research data where relevant, including, but not limited to, raw data, processed data, software, algorithms, protocols, methods, and materials.

v) Journal’s policy on ethical oversight.

Research involving human subjects, human material, or human data, must have been performed in accordance with the [Declaration of Helsinki](#). Where applicable, the studies must have been approved by an appropriate ethics committee and upon initial submission the authors should include a statement within the article text detailing this approval, including the name of the ethics

committee and reference number of the approval. Authors are expected to follow their institutional policies for research ethics.

vi) Journal's policy on intellectual property.

JLPE is an open access journal which means that all content is freely available without charge to the user or his/her institution. Users are allowed to read, download, copy, distribute, print, search, or link to the full texts of the articles, or use them for any other lawful purpose, without asking prior permission from the publisher or the author. All articles in the Journal are published under a CC BY-NC-SA license.

The Journal of Law and Political Economy does not require copyright transfer, only permission to publish and archive the article. Copyright holders retain copyright ownership, granting a nonexclusive license to the Journal, eScholarship and any future publishers of the Journal to publish the article, meaning that the author may also publish it elsewhere, in accordance with the CC BY-NC-SA license. Before submitting an article to the Journal, please be sure that all necessary permissions have been cleared in any third-party material. All articles published in the Journal are subject to the Journal's author agreement, which is available in the first step of the submission process or by contacting us to request a copy.

vii) Journal's options for post-publication discussions and corrections.

When authors discover significant errors or inaccuracies in their own published work, it is their obligation to promptly notify the Journal's editors or publisher and to cooperate with them to either correct the paper in the form of an erratum or to retract the paper. If the editors learn from a third party that a published work contains a significant error or inaccuracy, they may ask the author(s) to respond to their concerns and then it is the authors' obligation to promptly correct or retract the paper or provide evidence to the Journal editors of the correctness of the paper.
