

Thermal and Magnetic Measurements on YBa₂Cu₃O_{7-y}

Specific heat measurements in zero and 7T magnetic fields from 0.4 to 100K, and magnetic susceptibility measurements above T_c have been made on a series of polycrystalline samples of $YBa_2Cu_3O_{7-y}$ (YBCO). These measurements reveal a number of regularities. The size of $\Delta C(T_c)/T_c$ for the samples $[\Delta C(T_c)]$ is the jump in the specific heat at T_c 1 appears to vary linearly with the low temperature value of the Debye θ , with the entropy change between \approx 85K and T_c induced by the application of a 7T magnetic field, and with the variation of the observed low temperature y with magnetic field, dy/dH. On the other hand the temperature-independent part of the magnetic susceptibility above T_c appears to be essentially independent of $\Delta C(T_c)/T_c$. These results are consistent with the idea that samples of YBCO below T_c are a mixture of superconducting and normal phases.

INTRODUCTION

We have made specific heat, C, and magnetic susceptibility measurements on numerous polycrystalline samples of $YBa_2Cu_3O_{7-y}$ (YBCO) prepared in a number of different laboratories and by several preparation methods. A principal aim of these measurements has been to determine whether there exist correlations in the height of the specific heat jump at T_c , $\Delta C(T_c)/T_c$, with other measured quantities. We have previously noted (Phillips, et al. 1988, hereafter referred to as P1) that the size of $\Delta C(T_c)/T_c$ appears to depend upon the existence of localized Cu^{2+} moments that are thought to reside in the YBCO lattice. results reported in P1 suggest that, because of the pair-breaking role of these moments, a fraction of a typical YBCO sample remains normal below T_c . They also suggest that a fully superconducting sample would have $\Delta C(T_c)/T_c$ 76 mJ/mole K^2 and no linear term in the low temperature specific heat. The more typical YBCO sample, in addition to having a term in C that is linear at low temperatures, the size of which is related to $\Delta C(T_c)/T_c$, should have other measureable properties which are correlated with the jump in the specific heat at T_c . CORRELATIONS

Figure 1 is a graph of C/T vs. T for a typical YBCO sample between 80

and 95 K in zero applied field and in a field of 7T. The shaded area in Fig. 1 represents the entropy decrease, ΔS , between T_{χ} (*86K for this sample) and T_{C} that is produced by the application of the field. If the zero field superconducting transition is incomplete (inclusions of normal material below T_c), then both the specific heat anomaly at T_c and ΔS should reflect this fact. In Fig. 2 ΔS for various samples is plotted versus $\Delta C(T_c)/T_c$, where this latter quantity is determined from an entropy-conserving construction on the zero field C/T vs. T data (see Fisher, et al. 1988). It is evident that an essentially linear relationship between ΔS and $\Delta C(T_c)/T_c$ holds.

Also plotted in Fig. 2 is dy/dH, where dy/dH is the change with applied magnetic field of the measured low temperature y. The increase in y with increasing applied field is consistent with the behavior observed in type II superconductors (Radebaugh and Keesom, 1966). That dy/dH is a linear function of $\Delta C(T_c)/T_c$ is understandable if one assumes that both are extensive variables which depend upon the fraction of a sample which is superconducting in zero applied field. It should be noted that dy/dH and ΔS are not independent of one another. The Third Law of Thermodynamics requires that $S(T_c, T) = S(T_c, 0)$. If we assume that at temperatures below T_x (see Fig. 1), $C(T, T) - C(T, 0) = \Delta y$ T, where $\Delta y = (dy/dH)$ 7T, then the Third Law requires that $\Delta y T_x$ should equal the shaded area in Fig. 1. For all of our samples this equality is found to hold within a few per cent.

Fig. 2 also indicates that χ_0 , the temperature independent part of the magnetic susceptibility above T_c , is essentially independent of $\Delta C(T_c)/T_c$, in contrast to the results obtained in (Junod et al. 1988). If, with Junod, we assume that the measured χ_0 is not very different from χ_p , the Pauli susceptibility (the core diamagnetic and the Van Vieck paramagnetic terms are assumed to cancel, approximately), then we can estimate the value of y, the Sommerfeld constant for the normal material from χ_0 . Our value of 2.9x10⁻⁴ emu/mole YBCO yields a value for y of ~21 mJ/mole K^2 . While it is likely to be fortuitious, this value is in rough agreement with 16 mJ/mole K^2 , the low temperature y value predicted in P1 for a sample with $\Delta C(T_c)/T_c=0$.

The fourth plot in Fig. 2 shows that θ_0 , the Debye theta obtained from the T³ contribution to the low temperature specific heat, also increases with increasing $\Delta C(T_c)/T_c$. This result is consistent with that obtained by Eckert (Eckert, 1989), but is difficult to understand in terms of the model proposed in P1. This variation of θ_0 may indicate either that the localized Cu²⁺ moments in the YBCO lattice produce a lattice softening or that there is a

difference in θ_0 for the superconducting and normal phases. However, so far as we know, neither interpretation has other exerimental support. CONCLUSIONS

Because the data plotted in the figures are obtained by looking at small differences between large numbers, there is considerable scatter in some of the in particular some of the parameters for the two Zn-doped samples $(Cu_{2.97}^{Zn}_{0.03})$ and $Cu_{2.85}^{Zn}_{0.15}$) depart considerably from the trends established by data on the other samples, and it may be that for these samples the simple model put forward in P1 must be modified. Nonetheless, the above results make it clear that a number of properties of polycrystalline YBCO can be correlated with $\Delta C(T_c)/T_c$, and that, therefore, this parameter may well be the best available indicator of sample quality. The model presented in P1 implies that, once impurity-phase effects have been accounted for, other departures from "ideal" superconducting behavior can be understood by regarding YBCO as being in a "mixed state" in which the amount of normal material below T depends upon the concentration of localized Cu²⁺ moments present in the lattice. Juned (Junod, et al. 1989) has shown that a number of properties of YBCO depend upon the oxygen deficiency in the samples. It is possible that this oxygen deficiency is responsible for the localized moments in the lattice, and if so, there may exist a simple relationship between these two quantities that merits investigation.

Fig. 2. ΔS , dy /dH, θ_0 , and χ_0 versus T. See text for the definitions of these quantities.




