FRANCISCO JAVIER DÍEZ DE REVENGA. Professor of Spanish Literature at the University of Murcia, received his PhD in Romance Philology at the University of Murcia. His areas of specialization are Medieval, Golden Age, and Twentieth-Century Spanish Literature. His numerous publications include *Edición de obras (selección) de Alfonso X el Sabio*.

ROSALIE GIMENO received her PhD from Case Western Reserve University specializing in early Spanish Theater. Her publications include the "*Estudio preliminar*" of *Obras dramáticas, I* (Cancionero de 1496) and *Teatro: Segunda producción dramática*, both by Juan del Encina, with two current projects of "Juan del Encina's *Cancionero* of 1501, Seville," and *Juan Ruiz, Libro de buen amor: The Carnal Life*.

JOAQUÍN GIMENO CASALDUERO, Professor of Spanish, UCLA, received his degrees at the University of Murcia. His specialization is Spanish Literature of the Middle Ages, the Renaissance, and the Nineteenth Century. His publications include *La imagen del monarca en la Castilla del Siglo XIV* and *El misterio de la redención y la cultura medieval*. He is presently working on "El prólogo de la *Celestina*."

ROBERT A. GRANBERG, now teaching at Yale University, received his PhD in Hispanic Languages and Literatures from UCLA. He is currently studying the relationship between speech and writing in Golden Age texts and the problem of dating works in the traditions of the *mester de juglaría* and the *mester de clerecía*.

His specialization is Renaissance, Medieval and Golden Age Spanish Literature. Current projects include a book about the interaction between politics and literature in the reign of Juan II of Castile.

JUAN JOSÉ PRAT FERRER is working on his dissertation at UCLA on Spanish Medieval Literature. Several of his short stories and poems have been published in *Diario La Prensa* as well as sonnets and *liras* in *Mester*. His current projects include "La estructura tripartita de Fernán González" and "Serranas y serranillas en España."

ENRIQUE RODRÍGUEZ CEPEDA, Professor of Spanish, UCLA, specializes in Spanish Literature of the Golden Age and Eighteenth Century. His publications include several articles about "Los Quijotes del siglo XVIII" and *Romancero impreso en Cataluña*. His current project is *La lectura icónica del Quijote*.

LUIS MIGUEL VICENTE GARCÍA is a doctoral student at UCLA, with a specialization in Medieval and Golden Age Spanish Literature. His published articles include "El lamento de Pleberio: Contraste y parecido con dos lamentos en Cárcel de Amor" (*Celestinesca* 12) and "Un ejemplo de autobiografía popular" (*Revista de Folklore* 91). He is currently writing his dissertation, *El libro conplido de los iudizios de las estrellas*.

CATHERINE HENRY WALSH received her C.Phil. from UCLA. Her specialization is Eighteenth- and Nineteenth-Century Spanish Literature.
