## **Editor's Introduction, Winter 2025**

#### **Issue Contents**

We begin by focusing on legislative staffing, a topic which is understudied, especially at the state legislature level. Drawing on a unique data set, Michelangelo Landgrave's lead article offers a quantitative analysis of how the California State Assembly utilizes different groups of staffers. He determines that Hispanic and Asian American Pacific Islander staffers are disproportionately placed in constituency service positions. This finding has implications not only for California but for American legislative bodies more generally.

Next, we continue the CJPP tradition of publishing articles examining budgeting in the western states. We feature ten such articles, including detailed studies of budgeting in Arizona and Nevada, two states that have been missing from our analyses in recent years. In 2024, we saw sharp divisions among the states in terms of overall fiscal health, with some states running surpluses and others facing deficits. These fiscal health differences interacted with increasingly sharp partisan splits to affect how much was invested in public education, whether any tax relief was provided, and the like. While the extent of Democratic or Republican control of the levels of power was especially critical for budgetary decisions, intraparty splits about budget related matters were also significant in some states.

The inclusion of the budgeting articles underscores the journal's long-standing interest in comprehensive, fine-grained comparisons of policies and politics. I am unaware of any other publication that offers such detailed cross-state analyses of budgetary decisions, for example.

#### **Editorial Transition**

This is my last issue as the CJPP editor. I am proud to have taken on this role and remain strongly committed to the journal's mission. I am also excited that Professor Amal Kumar, my departmental colleague, will be the new editor. Amal's creativity and scholarly thoughtfulness will serve the CJPP well.
