the odds ratio and 95% confidence interval values for the variable "history of prior HCV testing" from odds ratio "-0.08" to 0.73 and the 95% confidence interval value from "-0.39 to 0.24" to "0.21-2.48" and the confidence interval for the variable "Extended shelter stay during treatment" from "-0.87 to 1.15" to "0.87 to 1.15".
