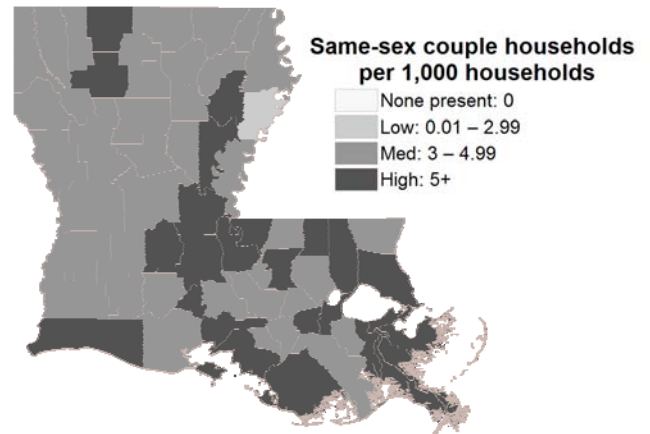

Using data from the U.S. Census Bureau, this report provides demographic and economic information about same-sex couples and same-sex couples raising children in Louisiana. We compare same-sex “unmarried partners,” which the Census Bureau defines as an unmarried couple who “shares living quarters and has a close personal relationship,” to different-sex married couples in Louisiana.<sup>1</sup>



In many ways, the more than 9,000 same-sex couples living in Louisiana are similar to married couples. According to Census 2000, they live throughout the State, are racially and ethnically diverse, have partners who depend upon one another financially, and actively participate in Louisiana’s economy. Census data also show that 25% of same-sex couples in Louisiana are raising children. However, same-sex couples, especially those with children, have fewer economic resources to provide for their families than their married counterparts: they have lower household incomes and lower rates of homeownership.

### SAME-SEX COUPLES AND THE LGB POPULATION IN LOUISIANA

- In 2000, there were 8,808 same-sex couples living in Louisiana.<sup>2</sup>
- By 2005, the number of same-sex couples increased to 9,006.<sup>3</sup>
- In 2005, there were an estimated 102,315 gay, lesbian, and bisexual people (single and coupled) living in Louisiana.<sup>4</sup>

### INDIVIDUALS IN SAME-SEX COUPLES ARE DEMOGRAPHICALLY AND GEOGRAPHICALLY DIVERSE

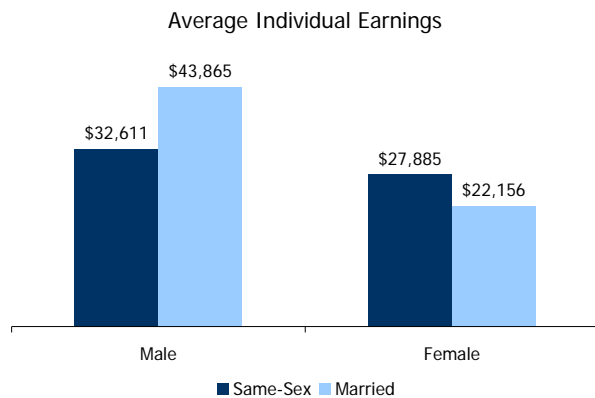
- There are more female same-sex couples (53%) than male same-sex couples (47%) in Louisiana.<sup>5</sup>
- Individuals in same-sex couples are, on average, 39 years old, and significantly younger than individuals in married couples (47 years old) in Louisiana.

- Same-sex couples live in every parish in Louisiana and constitute 1.0% of coupled households and 0.5% of all households in the state. Orleans Parish reported the most same-sex couples with 1,768 couples (0.94% of all households in the county), followed by Jefferson Parish with 998 couples (0.57%), and East Baton Rouge Parish with 796 couples (0.51%). The parishes with the highest percentage of same-sex couples are Orleans Parish (0.94% of all county households), Pointe Coupee Parish (0.63%), Claiborne Parish (0.59%), and Catahoula Parish (0.59%).<sup>6</sup>
- Louisiana’s same-sex couples are more racially and ethnically diverse than their married counterparts: 28% of same-sex couples are nonwhite, compared to 24% of married couples.

### PEOPLE IN SAME-SEX COUPLES ARE ACTIVELY ENGAGED IN THE STATE ECONOMY

- Individuals in same-sex couples in Louisiana are significantly more likely to be employed than are married individuals: 76% of individuals in same-sex couples are employed, compared to 62% of married individuals.

- Contrary to a popular stereotype, the annual earnings of men in same-sex couples are significantly lower than those of married men. On average, men in same-sex couples in Louisiana earn \$32,611 each year, significantly less than \$43,865 for married men. The median income of men in same-sex couples in Louisiana is \$28,600, or 18% less than that of married men (\$35,000).
- Women in same-sex couples in Louisiana earn an average of \$27,885 per year (with a median of \$24,000), more than married women, whose earnings average \$22,156 (with a median of \$18,000). Women in same-sex couples earn less than married men as well as men in same-sex couples.



- Individuals in same-sex couples in Louisiana are more likely to work in the private sector: 74% of individuals in same-sex couples work in the private sector, compared to 69% of married individuals; 17% of individuals in same-sex couples work in the public sector, compared to 18% of married individuals; and 9% of individuals in same-sex couples are self-employed, compared to 12% of married individuals.
- Individuals in same-sex couples are significantly more likely to have a college degree: 32% of individuals in same-sex couples and 21% of married individuals have earned a college degree.
- Despite the military's historic policies of excluding gay men and lesbians from service, individuals in same-sex couples have served in the military: 8% of individuals in same-sex couples are veterans, compared to 16% of married individuals.

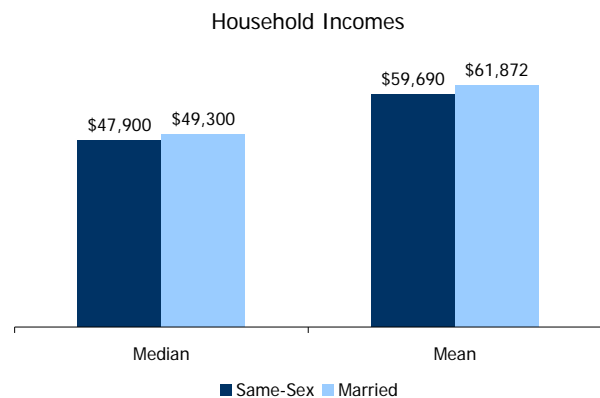
### SAME-SEX PARTNERS IN LOUISIANA DEPEND UPON ONE ANOTHER IN WAYS THAT ARE SIMILAR TO MARRIED COUPLES

- Couples in which one partner does not work or earns significantly less than the other partner may indicate financial interdependence. 29% of same-sex couples have only one wage earner, compared to 35% of married couples.

- The income gap between same-sex partners is \$19,124, compared to \$25,885 for married spouses.
- 32% of same-sex couples have at least one partner who is disabled, compared to 33% of married couples.
- 6% of same-sex couples have at least one partner who is age 65 or older, compared to 18% of married couples.

### SAME-SEX HOUSEHOLDS IN LOUISIANA HAVE FEWER ECONOMIC RESOURCES THAN MARRIED HOUSEHOLDS

- The median income of same-sex coupled households in Louisiana is \$47,900, less than that of married couples (\$49,300). The average household income of same-sex couples is \$59,690, less than \$61,872 for married couples.

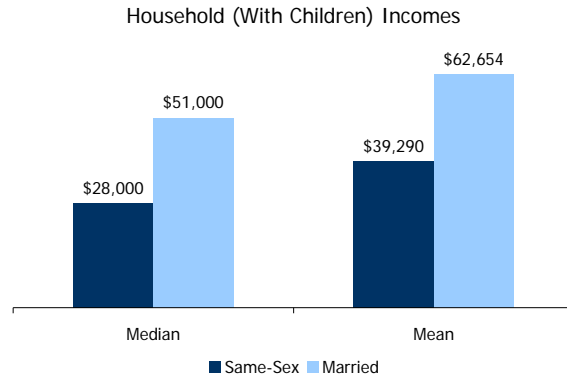


- Same-sex couples are significantly less likely than married couples to own their homes: 57% of same-sex couples in Louisiana own their home, compared to 84% of married couples.

### SAME-SEX COUPLES ARE RAISING CHILDREN IN LOUISIANA, YET WITH FAR FEWER ECONOMIC RESOURCES THAN MARRIED PARENTS

- About 25% of same-sex couples in Louisiana are raising children under the age of 18.
- As of 2005, an estimated 4,157 of Louisiana's children are living in households headed by same-sex couples.<sup>7</sup>
- In Louisiana, married and same-sex couples with children under 18 in the home have, on average, 2 children.
- More than 2% of Louisiana's adopted children (or 469 children) live with a lesbian or gay parent.<sup>8</sup>
- 50% of same-sex parents have only one wage earner, compared to 37% of married parents.

- Same-sex parents have far fewer financial resources to support their children than married parents in Louisiana. The median household income of same-sex couples with children is \$28,000, or 45% lower than that of married parents (\$51,000). The average household income of same-sex couples with children is \$39,290, significantly less than \$62,654 for married parents.
- While 49% of same-sex couples with children own their home, a significantly larger percentage of married parents (80%) own their home.



## CONCLUSION

Census data provide valuable information about gay and lesbian couples in Louisiana. While in many respects Louisiana’s same-sex couples look like married couples, same-sex couples—especially those with children—have fewer economic resources to provide for their families and lower rates of homeownership than married couples.
