Dear readers,

After several dormant years, we are excited to relaunch the *Berkeley Undergraduate Journal of Classics*! We would like to thank the UC Berkeley Classics department, especially undergraduate adviser Cassandra Dunn, for their guidance and support with restarting the journal. In addition to academic articles, we are thrilled to begin what we hope will be a new tradition of publishing creative works.

Without further ado, we present to you the six exceptional pieces we have selected, all of which touch upon distinct areas of the world of classical antiquity. In “The Princess, The Pauper and The Perpetrator: A Trinational Electra in the Twentieth Century,” Will Shao analyzes how three twentieth-century playwrights incorporated elements from their sociopolitical environs into their adaptations of the Electra myth, and their significance. L. M. Martins vividly captures the rebellious spirit of Medea in the poem “Medea: Incarnate Queen of Disorder,” bringing the ancient queen to life in the modern world through verse. In “Indo-European Poesy and the ‘Ship of State’ in Aristophanes’s *The Frogs*,” Arjun Srirangarajan explores the importance of the parallels between analogies of poetry composition and ship carpentry in *The Frogs*. “‘The Realm of Truth Confronting its Shadowy Other’? The Reality of Elite Self-Distancing Narratives in Classical Literature” by Karl Ulas-Ono discusses the contrasts between the representation of elite versus non-elite spaces in classical literature. Sojeet Sharma’s “Woman of Tiryns” beautifully recreates a Mycenaean fresco from Bronze Age Tiryns, illustrating in vibrant watercolor a Mycenaean woman carrying an ivory pyxis. “The Indo-European Religious Background of the Gygēs Tale of Hērodotos” by Ethan Rite situates the Gygēs story from the *Histories* within a deeper Indo-European context, examining narratives of sacred marriage in a variety of ancient civilizations.

This past year has been a challenging one for all of us, and we are so grateful for everyone who submitted to BUJC this spring, most especially our authors and creators, without whose hard work and patience this issue would not have been possible. We are honored to be a part of sharing their scholarship and creativity with the world, and we hope you enjoy their works as much as we do.
