For almost four decades it has recognized how common law, statutes, legislative policy, and politically popular propositions impact the Latino community. The *Review* publishes articles, student-written comments, and speeches.

Our editorial process allows authors to publish high-quality pieces. All articles go through several rounds of substantive and formatting edits. Our diverse staff is made up of members who are dedicated to the advancement of Latino scholarly commentary, analysis, and legal work. The *Review* offers a proper forum where innovative, timely, practical, and controversial viewpoints addressing law or policy issues relating specifically to Latinas/os and other people of color are expressed. The *Review* is committed to not only acting as a medium for academic legal, judicial, and legislative analysis, but also as a blueprint for scholars, practitioners, policymakers, and advocates in establishing a progressive agenda for our community's future.

The *Review* will give preference to articles under 25,000 words in length—the equivalent of 50 law review pages — including text and footnotes. We will not publish articles exceeding 35,000 words — the equivalent of 70-75 law review pages — except in extraordinary circumstances. We prefer submissions via ExpressO. Please note that if you are submitting via ExpressO, we do not send a separate acknowledgement of receipt; the only acknowledgement that your manuscript has been received will come from ExpressO.
