BEATRICE BARBALATO è Direttore della rivista internazionale Mnemosyne o la costruzione del senso, Presses Universitaires de Louvain, Université catholique de Louvain, Belgique.

James Fishburne is a Ph.D. candidate in art history at UCLA. His research interests include Renaissance portrait medals and coins, portraiture, and the Renaissance papacy.
