ROBERTA JOHNSON, who received her Ph.D. in Spanish from UCLA, is Professor Emerita from the University of Kansas where she was Department Chair and Director of the Hall Center for the Humanities. She has published the following books: *Carmen Laforet* (1981), *El ser y la palabra en Gabriel Miró* (1985), *Crossfire: Philosophy and the Novel in Spain 1900-1934* (1993), *Las bibliotecas de Azorín* (1986), and *Gender and Nation in the Spanish Modernist Novel* (2003). She has also published more than 60 articles on twentieth-century Spanish prose in journals such as *Hispania*, *Revista Canadiense de Estudios Hispánicos*, *Revista de Estudios Hispánicos*, *Anales de la Literatura Española Contemporánea*, and *Letras Peninsulares* (among others). Johnson has held grants and fellowships from the Fulbright Program, the John Simon Guggenheim Foundation, the National Endowment for the Humanities, the Graves Foundation, the Spanish Ministry of Culture, and the Rockefeller Foundation.

LIZY MOROMISATO is a 4th year Ph.D. student in the Department of Spanish and Portuguese at UCLA, where she also received a B.A. in Linguistics and Spanish in 2000. Lizy's field of study is Spanish-American colonial literature, and her research interests include the baroque sermon, mysticism, and historical linguistics. Her doctoral dissertation will tentatively focus on the literary discourse about St. Rose of Lima from the 17th to the 19th century, and the construction of Rose as a symbol for national identity. Lizy is also a founding member of CECI (Centro de Estudios Coloniales Iberoamericanos).

ISABEL MOUTINHO is a lecturer in Spanish and Portuguese at the School of Historical and European Studies, La Trobe University, Australia. Her main research area is contemporary Portuguese literature, particularly the novels dealing with the colonial wars in Africa (the subject of her dissertation). Her other research interests include contemporary European comparative literature, literature and globalization, and literatures from Portuguese-speaking African countries, as well as from Timor. She has published book chapters and many articles in journals of literary criticism in Portugal, Australia and the United States, as well as

in electronic international publications. She is co-editor of the volume *Paths of Multiculturalism* (Lisbon: 2000).

CLAUDIA PARODI is a Professor of Spanish and Portuguese at UCLA. She has published numerous articles, reviews and books. She is the founding director of CECI (Centro de Estudios Coloniales Iberoamericanos), housed in the Department of Spanish and Portuguese at UCLA.

MARISOL PÉREZ, a doctoral candidate at UCLA, is currently writing her dissertation on Rosario Castellanos's continued relevance on both sides of the U.S./Mexico border, establishing connections between Castellanos and Chicana writers. Her work is reflective of her research in the fields of contemporary Latin American and Chicano literature, as well as Critical Feminist Studies. She received her M.A. at UCLA.
