It has been a traditional practice for the Chair-Elect of the conference to deliver the closing remarks. The first Vertebrate Pest Conference was held in 1962 (44 years ago), followed by the second conference held in 1964. Since the early years, it was decided that the conferences be held bi-annually, which is unique in that it attracts record numbers of participants. This year, the conference drew 332 registered participants. In addition to those from across the U.S., a total of 26 participants represented 7 countries (Australia, Canada, Israel, Kenya, New Zealand, and the U.K.).

Approximately 90 papers were presented, plus 13 poster presentations. Included in participants was a record number of students—26 in all, many of whom presented either oral papers or posters.

Currently, the Vertebrate Pest Council is comprised of 19 active members, a dedicated group of professionals who are committed to providing you with a quality educational program covering a wide variety of conventional, as well as controversial, topics. The Council members provide their services voluntarily, with membership ranging from 44 years (Dr. Walter E. "Howdy" Howard), and 42 years Rex E. Marsh (who, unfortunately, was unable to attend this conference), the two longest-serving Council members, both of whom have provided valuable guidance.

I would like to extend my gratitude to conference chair John O'Brien, from the Nevada Department of Agriculture, who worked very hard the past two years. Many thanks are due to Terry Salmon, program chair, and his committee for providing an outstanding program. Having served in public health for over 40 years, I am extremely pleased to note that the program agenda included a special symposium on wildlife diseases and their affect on human and occupational health-related issues. In addition to being the program chair, Terry also chaired the continuing education committee, receiving valuable assistance from Charlotte Carson, representing PAPA. Terry has also served (on his own time) as the business manager of the VPC for more than 20 years, and we are assuming that he has "kept the books" accurately, as we have not, (repeat) not yet been interrogated by IRS

Bob Timm and Amber Shrum also handled the tedious and laborious task conference registration. I would like to especially thank Amber for all the extra effort she contributed toward making this conference a success. In addition, Bob Timm is also the *Proceedings* editor. I encourage the speakers to submit their manuscripts to Bob on a timely basis, in order that the *Proceedings* can be prepared and distributed to all the attendees without delay.
