SORAYA ALAMDARI is a Doctoral Candidate at UCLA specializing in Colonial Spanish American Literature. She is currently writing her dissertation on Francisco de Vitoria's lectures about the Indians of the New World. She is part of the editorial board of *Mester*.

SYLVIA BLYNN is a Doctoral Candidate at UCLA specializing in contemporary Spanish American Literature. She is currently writing her dissertation on the dramatic works of Mario Vargas Llosa.

VERONICA CORTINEZ is an Associate Professor in the Department of Spanish and Portuguese at UCLA. She received her M.A. and Ph.D. from Harvard University. Professor Cortínez specializes in Colonial and Contemporary Spanish American literature, and her forthcoming publications include: *Memoria original de Bernal Díaz del Castillo* (UNAM), *Albricia: La novela Chilena de fin de siglo* (Editorial Cuarto Propio), and *Cine a la Chilena: las peripecias de Sergio Castilla* (Ediciones Universidad Andrés Bello). Among numerous publications he is the author of *The Loa of Sor Juana Inés de la Cruz* (York Press). His current research involves the Don Juan theme in Mexican theatre, the works of Joaquín Bestard, ekphrasis in Rima de Vallbona and Carlos Morton, the works of Rosa María Britton, and the imaginary town in Spanish American literature.

STEVEN HANLEY is a graduate student of Spanish at Columbia University. He received a B.A. in Economics from the George Washington University, and for the past 7 years has worked as a freelance Spanish/Portuguese translator specializing in law, telecommunications, information technology and banking.

FERNANDO IWASAKI CAUTI is a writer and historian.
