**THOMAS BENDER** is University Professor of the Humanities and Professor of History at New York University. In the late 1990s he organized a series of international meetings that resulted in an edited volume, *Rethinking American History in a Global Age* (2002), and later authored *A Nation among Nations: America's Place in World History* (2006). His current project, titled *An American History: The Making of Freedom and Unfreedom in U.S. History*, is under contract with Farrar Straus and Giroux. Since NYU became a “global university” he has spent time flying around and teaching NYU students (and going to committee meetings) on different continents.

**ISABEL DURÁN** is Professor of American Literature and Chair of English at the Complutense University of Madrid (Spain). Her research and publication record in gender studies, literature, autobiography and ethnicity includes an eight-volume gender studies collection (the latest volume, titled *Negotiating Gendered Spaces*, published in 2013) and her book *Autobiography: Female Versions in 20th Century American Literature* (in Spanish). She is also the coeditor of *Miradas Transatlánticas/Transatlantic Vistas: Cultural Exchanges between Europe and the US* (Fundamentos, 2011).

**EMRON ESPLIN** is Assistant Professor of English at Brigham Young University, where he teaches courses in US literature and inter-American literary studies.

**CHRISTOPHER T. FAN** is a PhD candidate in English at UC Berkeley, where he is completing his dissertation, “American Techno-Orientalism: Speculative Fiction and the Rise of China.” He is also a contributing editor at *Hyphen* magazine, which he cofounded. His writing has appeared there as well as *The New Inquiry* and *Post45: Peer Reviewed*.

**SHELLEY FISHER FISHKIN** is the Joseph S. Atha Professor of Humanities, Professor of English, and Director of American Studies at Stanford University, where she is also Co-Director of the Chinese Railroad Workers in North America Project. She is the author, editor, or co-editor of over 40 books, and has published over 100 articles, essays, and reviews. Her work has been translated into Arabic, Chinese, Georgian, Italian,

Japanese, Russian, and Spanish. She is a past president of the American Studies Association.

**GENEVA M. GANO** is Assistant Professor of Literature at Antioch College in Yellow Springs, Ohio. Her research focuses on the intersections between literature, culture, and geography in North America. She is currently at work on a research project that explores how the politics and aesthetics of the Mexican Revolution influenced the development of US modernism.

**JERRY GARCÍA** is Associate Professor of Chicano Studies and History at Eastern Washington University.

**KYLE GARTON-GUNDLING** earned his PhD from the University of Maryland, College Park. He currently teaches writing at the University of Scranton. His research interests include multiethnic studies, literature and religion, and the ethics of cross-cultural adaptation. He is working on a book project tentatively titled “Rewriting Eastern Wisdom: Buddhism and Hinduism in American Literature from Jack Kerouac to Maxine Hong Kingston.”

**INGRID GESSNER** is Assistant Professor of American Studies at the University of Regensburg, Germany. She has also taught and studied at Johannes Gutenberg University Mainz, Germany, the University of California, Davis, and the University of Michigan, Ann Arbor. Her most recent book is situated in the medical humanities and explores the cultural dimension of yellow fever in nineteenth-century US-American literature and visual culture. She is the author of *Collective Memory as Catharsis? The Vietnam Veterans Memorial in Public Controversy* (2000) and the award-winning *From Sites of Memory to Cybersights: (Re)Framing Japanese American Experiences* (2007). She has coedited special journal issues on “Iconographies of the Calamitous in American Visual Culture” (*Amerikastudien/American Studies* 58, no. 4 [2013]) and on “Commemorating World War II at 70: Ethnic and Transnational Perspectives” (*American Studies Journal* 59 [2015]).

**ADAM GOLUB** is Associate Professor of American Studies at California State University, Fullerton. His research and teaching interests focus on popular culture, the history of childhood and education, and the globalization of American culture. His essays have appeared in *American Quarterly*, *Film and History*, *Transformations*, and *Hybrid Pedagogy*.

**ZAREENA GREWAL**, a historical anthropologist and documentary filmmaker, is Assistant Professor of American Studies and Religious Studies at Yale University.

**PERIN GUREL** is Assistant Professor of American Studies at the University of Notre Dame, specializing in transnational American Studies with a focus on the United States and the Middle East. She is also a research faculty fellow in Gender Studies at Notre Dame and a fellow of the Yale Initiative for the Study of Material and Visual Cultures of Religion. Her academic interests include comparative studies of gender, sexuality, and the intersections of vernacular culture with international relations. She is currently working on her first book, *Wild Westernization: Gender, Sexuality, and the United States in Turkey*, which explores how conflicts over the concept of “westernization” in Turkey have historically influenced US–Turkish relations, cultural production, and sexual politics.

**ABDELMAJID HAJJI** is a full professor at Moulay Ismail University in Meknes and an adjunct professor at Al Alakhawayn University in Ifrane, Morocco. He teaches such subjects as Media, International Communication, Conflict in Media, and Peace and Conflict Resolution.

**SCOTT HALES** has a PhD in English from the University of Cincinnati. His critical essays on American and Mormon literature have been published in *Religion and the Arts*; *The International Journal of Comic Arts*; *The Edgar Allan Poe Review*; *Dialogue: A Journal of Mormon Thought*; and *War, Literature, and the Arts*. He has also published book reviews in the *Mormon Studies Review*, *Religion and Popular Culture*, and *Irreantum*.

**UDO J. HEBEL** is Professor and Chair of American Studies at the University of Regensburg, where he has served as President since 2013. He has published close to sixty articles in national and international journals of American Studies. His most recent edited volume, *Transnational American Studies*, was published in 2012. At this point, he is preparing an annotated edition of eighteenth- and nineteenth-century New England anniversary orations and a special journal issue on “South Africa and the U.S. in Transnational American Studies.”

**IFEOMA KIDDOE NWANKWO** is Associate Professor of English at Vanderbilt University. Her research centers on nineteenth- and twentieth-century US African American and Caribbean literature and culture (including the portions of Central America that border the Caribbean Sea).

**GREG ROBINSON** is Professor of History at Université du Québec À Montréal. He was recently awarded the 2015 Japan Residency by the Organization of American Historians and the Japanese Association for American Studies. He serves as the Forward Editor of *JTAS*.

**TEEMU RUSKOLA** is Professor of Law at Emory University's School of Law. He is coeditor of *Schlesinger's Comparative Law* (with Ugo Mattei and Antonio Gidi; Foundation Press, 2009) and coeditor (with David L. Eng and Shuang Shen) of a special double issue of the journal *Social Text* on "China and the Human" (2012). His publications have also appeared in *Michigan Law Review*, *Stanford Law Review*, *UCLA Law Review*, and *Yale Law Journal*.

**STEPHEN HONG SOHN**, a former University of California President's Postdoctoral Fellow (2006–2007), is Assistant Professor of English at University of California, Riverside. He is a member of the Advisory Board of *JTAS*.

**WILLIAM V. SPANOS** is Distinguished Professor of English and Comparative Literature at Binghamton University and the author of many books and essays on American exceptionalism, including *Shock and Awe: American Exceptionalism and the Imperatives of the Spectacle in Mark Twain's A Connecticut Yankee in King Arthur's Court* (Dartmouth College Press, 2013) and *Redeemer Nation: An Untimely Meditation on the American Vocation* (Fordham University Press, forthcoming 2015).
